5. If the 1st premium is not received before or on the 7th of the month of inception, then the inception date will be moved to the following month.
6. The premium is subject to review on an annual basis.
7. Burien Prime Solution Benefit is NOT exchangeable for cash/voucher/credit of any kind.
8. No paid up on death/disability/retirement. Family or dependants may take over payments.
9. Maximum number of children per family is five (5).
10. Child must be biological child of main member and share the surname with either the main member or spouse.
11. One policy per main member.
12. A waiting period of 6 months for insured persons below the age of 75 or 12 months for insured persons aged 75 and older will be applicable.
13. Debit order fee of R5.00 will apply for all debit order payments. (Not included in the quoted rates)
14. Errors and omissions exempted.
15. The above premiums are subject to change.
16. Benefit or policy increase will have a 6-month waiting period.

17. Member Plus Plans

Main Member:

Any person qualifying for insurance in terms of the policy who is younger than the maximum entry age of 75 years when entering into the policy.

The Main Member and Extended Family Members must be under the age of 75 years when joining.

Extended Family Members means:

- a) A Parent of the main member; or
- b) A Parent-in-law of the Main Member; or
- c) A brother of the Main Member; or
- d) A sister of the Main Member; or
- e) A relative of the Main Member (including a person who is not covered for benefits in terms of the definitions of "Child" and "Spouse") through blood or marriage, who is financially dependent upon the Main Member for the payment of such relative's funeral costs; or
- f) A child who ceases to qualify for insurance as a "Child" in terms of the Policy, provided that such child becomes an Extended Family Member immediately upon ceasing to be a Child and who is insured under this Policy for the extended Family Benefit.

Number of extended members allowed on a policy:

1+5 Main member and 5 extended family members

1+9 Main member and 9 extended family members

1+13 Main member and 13 extended family members

Total members allowed on a policy may not exceed 14 lives.

Extended family members may age from 0 – 75 years. No members allowed over 75 years.

No stillborn benefit available.

No waiting period for unnatural causes of death, provided that the policy incepted with G-Green Burien Marketplace (Pty) Ltd, and first premium was paid over to G-Green Burien Marketplace (Pty) Ltd before death.

12 Month waiting period for suicide.

If the Main Member and the Main Members Extended Family benefits have lapsed and he/she again becomes insured in terms of the policy, the above waiting periods will apply again.
